## MOTHERS DAY BONUS GIFT WITH PURCHASE 19<sup>th</sup> MARCH 2018 – 20<sup>TH</sup> MAY 2018 TERMS AND CONDITIONS

1. Information on purchasing Participating Products and how to make a claim to receive a Bonus Offer forms part of these Terms and Conditions (**Terms**). These Terms apply to the Promotion and submission of a claim for a Bonus Offer is deemed acceptance of these Terms.

2. The promoter is KitchenAid Australia Pty Ltd (ABN 50 601 363 419) of 6-8 Billbrooke Close, Cameron Park NSW 2285, Australia (**Promoter**).

3. The Promotion will be open from 12:00am Australian Eastern Daylight Time (AEDT) 19/3/2018 and will close on 11:59pm Australian Eastern Standard Time (AEST) on 20/05/2018 (**Promotion Period**). Purchases made outside the Promotional Period will be declared as void.

4. Entry is open to Australian and New Zealand residents aged 18 years and over (Eligible Claimants).

5. Employees, directors, management and contractors of the Promoter and other agencies, firms, retail staff or companies associated with the Promotion (including suppliers of Prizes), and their immediate families, are not eligible to enter. By entering this Promotion you represent that you are eligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

## **Participating Products**

7. Participating Product(s) refers to KitchenAid Stand Mixers and Food Processors purchased from a Participating Retailer. The eligible models of the Participating Products that form part of this promotion are:

a) Stand Mixers: KSM3311/KSM45A/150/160/170/180/7581/7590, KPM5, KPM50 and KSMC895 (Participating Product Stand Mixers); and

b) Food Processors: KFP1325, KFP1333 and KFP1444 (Participating Product Food Processors).

The Participating Products are subject to stock availability.

8. Commercial sales, second-hand purchases and trade seconds products, insurance claims, purchases denoted "Clearance" (including seconds) or Special Offers are excluded from this promotion, and any Participating Products purchased in these ways will not be eligible for the Bonus Offer.

9. Offer available to purchases made from authorized Participating KitchenAid Retailers only. Purchases purchases made through the KitchenAid online store at the URL <u>www.kitchenaid.com.au and</u> <u>www.kitchenaid.co.nz</u> (excluding the products identified in clause 8) are valid and will be accepted.

## **Bonus Offer**

10. An Eligible Claimant who purchases a Participating Product Stand Mixer can claim the Bonus Offer of only one (1) of the following attachments of their choice:

- a) Spiralizer (KSM1APC,RRP AU \$229/ NZ \$249);
- b) Fresh Prep Slicer & Shredder (KSMVSA, RRP AU\$169 / NZ \$199); or
- c) Pasta Roller (KSMPSA, RRP AU \$149 / NZ \$199).

For the avoidance of doubt, Eligible Claimants who redeem the Bonus Offer for a Participating Product Stand Mixer may choose only one (1) of the above three (3) options, and are not entitled to more than one (1) attachment.

11. An Eligible Claimant who purchases a Participating Product Food Processor can claim the Bonus Offer of a Dicing Kit Attachment (KFP13DC12, RRP AU\$169/ NZ \$169) only.
